AGENDA ITEM Consider a request to allow “Smokin Bro’s” to use the public right of way west of 223 W. Main on October 23-24, 2020.

SUMMARY RECOMMENDATION City staff recommends allowing the use of the right-of-way.

BACKGROUND The City of Independence received a request from “Smokin Bro’s” to use the sidewalk and parking on the West side of the Brewery. They will set up a tent and some picnic tables on October 23, 2020, at 5:00 p.m. and remove the tent and tables on October 24, 2020, after 9:00 p.m.

SUGGESTED MOTION I move to authorize Smokin Bro’s to use the sidewalk and parking on the West side of the Indy Brew Works on the East side of 9th Street on October 23-24.

Per our phone conversation, I would like to submit a request for the street department to put up a small block beside Indy Brew Works at 223 W Main for setup of a vending canopy. This would be on 9th Street directly to the west of the brewery. I have attached a small diagram and drawing of our canopy setup and requested location. Also, I have enclosed a Google Maps screenshot. The space requested would be where the Red X's are marked extending from inside Main street to the Alley way on South 9th Street well before it hits Maple. We feel like we only need a partial use of the street for only that half block range. We would potentially set the canopy up on Friday night October 23rd after 5pm. And we anticipate being out of the space by Saturday October 24th at 9pm. We feel this would help with social distancing and we DO have access to some picnic tables we could also setup in this area if it were blocked off for people to sit and eat at in the event the brewery is at capacity. Our canopy is approximately 12ft by 20ft. We can even assist the street department by setting the wooden road blocks onto the sidewalk Saturday night beside the brewery for pickup if this would help make it easier on them.
