**An Ordinance Amending Appendix D With
Regard to Rates and Fees Charged in the Park & Zoo**

BE IT ORDAINED by the Governing Body of the City of Independence, Kansas:

Section 1. Appendix D, Chapter 74, Parks & Recreation (1), is amended to read as follows:

(1) Park Building Rental Fees:

Entire enclosed 4-H Building	\$100 per day
Enclosed 4-H Building dining room & kitchen only	\$ 40 per day
Enclosed 4-H Building large room only	\$ 40 per day
East open 4-H Building	\$ 25 per day
Middle open 4-H Building	\$ 25 per day
Lone Chief Cabin	\$ 50 per day
Concession House	\$ 25 per day
Rock Kitchen	\$ 25 per day
Band Shell	\$ 30 per day
Shelter House	\$ 50 per day

In the event of cancellation, the renter must give three months' notice to receive a full refund for the building rental.

Section 2. Appendix D, Chapter 74, Parks & Recreation, is amended to add a paragraph (4) as follows:

(4) Activity Fees:

Carousel	\$.05 per ride
Miniature Train	\$.50 per ride
Miniature Golf	\$ 2.00 per 18-hole round

Section 3. This Ordinance shall take effect upon its publication in the official City newspaper.
