AGENDA ITEM Consider authorizing award of the Concrete Patching Bid.

SUMMARY RECOMMENDATION Authorize award to multiple parties.

BACKGROUND The City requires concrete patching work to be completed at various locations due to utility repair activity and required pavement maintenance (including pavement flowlines). We requested bids for this work, and received two responses (attached). It is recommended that the City award bids to both contractors, since there will likely times during the year when one or the other contractor may not be able to be responsive.

Since the bids were very close in cost, it is suggested that both be awarded the work at the higher bid amount of \$143 per square yard, which would increase overall costs of patching less than 3%.

SUGGESTED MOTIONS I move to authorize award of contracts for Concrete Patching to Goins Concrete and Construction and to Recrete Design Concrete + Construction at the unit cost of \$143.00 per square yard.
