**BACKGROUND** The City was contacted by Ray Rothgeb representing the Independence Historical Museum. (CONTENT OF EMAIL FROM FREEDOM'S FRONTIER)

Freedom's Frontier has applied for EDA Tourism funds, but have received feedback from their staff that our application will not be viewed favorably unless we obtain letters from **city, county or state officials** (e.g., **Mayor**, City Councilperson, County Commissioner, **City Manager**, etc), in both urban and rural areas, that indicate they believe what we do with the funding is anticipated to result in job growth.

We are planning to use the EDA grant funds to update our old (circa 2010) website and map so that all sites and partners are listed and are spectacularly promoted, as well as hire staff to help us with that updating and submitting content to our website and APP.

Would you be willing to find a local government official to sign and return the attached letter? I was extremely conservative and only estimated a growth of 2 jobs due to our efforts. Would you feel comfortable with that? If not, please revise so that it makes sense to you.
